The PhD in Legal Studies is a three-year program that forms first class scholars; our PhD graduates have an excellent track record in securing both academic and non-academic positions, including in international organizations. The program offers courses aimed at strengthening research skills, including methodology, interdisciplinarity and the connection between law and economics.

During the first semester of the first year, students are required to attend curricular courses. Subsequently, students are required to work mainly on their dissertation and other complementary research activities. In order to develop their thesis, students are encouraged to spend at least one period of stay at international universities or institutions.

Our program provides 8 three-year fellowships, which include tuition waiver, a generous stipend, and access to research funds. In addition, some tuition waivers are available. Starting from the second year of the program, students also have the opportunity to pursue salaried teaching and research assistantships. The PhD School offers further financial support for students seeking academic placement in prestigious institutions.

The program is composed of two curricula: **Business and Social Law/Diritto dell'impresa**, taught partly in Italian and partly in English, and **International and European Law**, taught entirely in English.

The **BUSINESS AND SOCIAL LAW** curriculum aims to examine the study of business law with an approach combining an interdisciplinary perspective, an international orientation and the analysis of the specific field of law chosen by each student (e.g. corporation, securities, competition, commercial contracts, bankruptcy, IPRs, labor law, white collar crime). The study of law, economics and social sciences complements business and legal studies.

The **INTERNATIONAL AND EUROPEAN LAW** curriculum seeks to foster excellent research in any topic in those areas, including, but not limited to, public international law, private international law, European economic and trade law, European constitutional law and European social law.

Alongside the compulsory first year courses, students will be offered a seminar series with invited speakers (leading academics, members of national, European and international courts, practitioners and civil servants), also enhancing networking possibilities. Furthermore, from the second year students are given the opportunity to contribute to the planning of seminar activities, so as to ensure maximum synergies between the latter and the PhD cohort research interests.

- Academic records (including thesis abstract)
- Research proposal
- Statement of purpose
- Up to two reference letters
- Other relevant documents (e.g. publications, other programs attended)

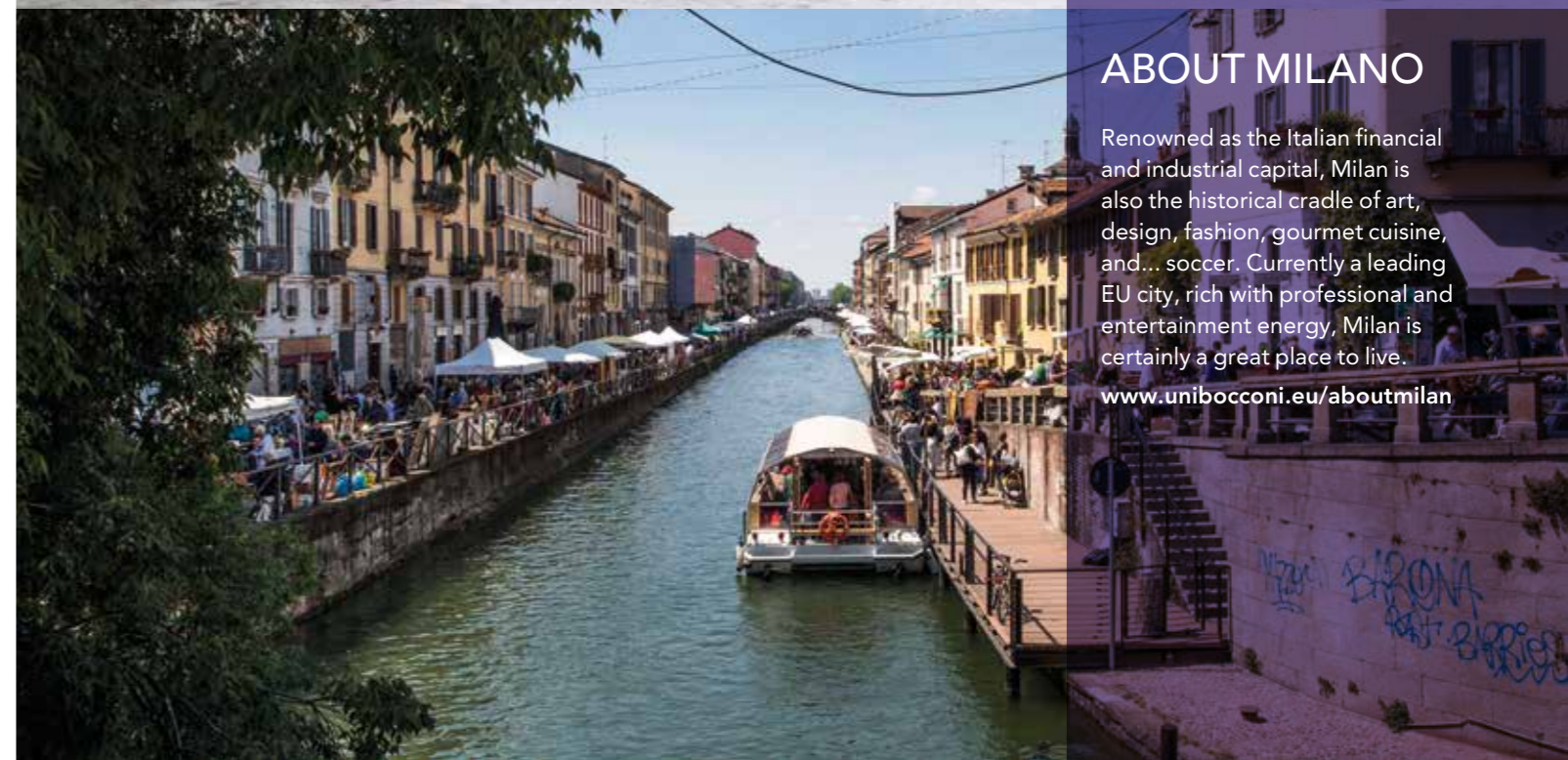
