CEMS Year 24-25: Timeline



Internship

8 consecutive weeks full-time abroad. Abroad = outside the Home School Country (outside Italy)

Timeline: during **Summer 2024 or after the end of academic activities of Term 2 24-25.**

It cannot be overlapping with the CEMS year (Block Seminar, term dates).

CEMS Graduation

1° CEMS Graduation available: December 2025

If you plan to Graduate from CEMS in December 2025, last graduation in Bocconi in October 2025.

2° CEMS Graduation available: December 2026

If you plan to Graduate from CEMS in December 2026, last graduation in Bocconi in October 2026.



CEMS Languages

All CEMS MIM graduates must have language competence in three languages, one of which is English.

The minimum language requirements are the following:

Language 1: English

- Mother tongue or Proficiency (fulfilled through every requirements and MIM Programme)

Language 2: any language

- Mother tongue or B1 oral / B1 written level

Language 3: any language

- Mother tongue or elementary level

RANKING - TIMELINE

- Mid-February: CEMS semester abroad in AY 2024 -2025 info available online
- Apply online from 28 February to the 5 March through www.cems.org/selection
 - register your personal data and language requirements;
 - ranking the whole list of CEMS Universities and your priority between destination and term.
- End of March: You will be informed on your assigned Host School



CEMS Semester Abroad

RANKING – RULE OF THE GAME

- Ranking of the destinations and priority expressed for the term or for the destination will be taken into consideration when working on the final allocation.
- The final allocation will take into consideration the average weighted on credits, according to the following **formula**: *Student academic weighted credit average (WA) * [Number of credits earned (NC) divided by the maximum number of credits that can be earned (MAX NC)].*
- The **calculation of credits** includes all the exams of the 1st semester of the 1st Master of Science year. Exams that are not part of the 1st semester of the 1st Master of Science year study plan (internship, languages, anticipated exams and anticipated curricular supplementary activities) are not included.
- Courses subdivided into **modules**: the credit points and the grades earned for the single modules passed will be taken into account and they can be viewed by printing the unofficial academic transcript at the Punto Blu.

CEMS Internship requirements

CEMS Internship requirements

Timeline: **after the end of academic activities of Term 2 24-25.**

It cannot overlap with the CEMS year* (Block Seminar, terms dates, Business project delivery).

Duration: **min. 8 consecutive weeks full-time abroad.** Abroad = outside the Home School Country (outside Italy).

Modality: in presence or hybrid. **NO fully-remote** internships are allowed.

Activation procedure: upload your internship and relevant documents (i.e. contract/Internship Agreement) on the **CEMS portal** to get pre-approval by CEMS Corporate Relations Coordinator.

***Check the partner school academic activities calendar in the factsheet, you must REFER to the HOST SCHOOL ATTENDANCE RULE to avoid any overlapping with the CEMS year.**

2 cases that can be evaluated:

- Summer 2024 → **If and only if there is no overlapping with the CEMS year.**
- Internships done **between the Bachelor and the Master of Science** programs → **if and only if all other requirements hold.**



IM Internship requirements

IM Internship requirements

Timeline: starting from **the end of first year academic activities***.

Duration: **min. 8 consecutive weeks full-time** (min. 35 hours per week) or 11 part-time (min. 20 hours per week).

Modality: in presence or hybrid. Fully-remote internships will be taken into consideration case by case by Bocconi Internship Office.

Activation procedures:

a) If in **Italy**, must be **activated before it starts** by the Internship Office based on **Bocconi Internship Agreement**; this **procedure** requires the Company to register on JobGate portal.

b) If **outside Italy** and the Company requires the **Bocconi Internship Agreement**, you follow procedure a).

b.2) If **outside Italy** and the Company provides you with a **contract**, you must fill out the **"Self-found internship abroad"** form, available on yoU@B.

*Internships done **between the Bachelor and the Master of Science** programs → **if and only if all other requirements hold.**

IM Internship – validation process

Once activated according to the procedure seen above, follow the IM [Credit recognition procedure](#) which entails:

- 1) **advance authorization** for credits recognition (you still have not started the internship nor acquired the credit yet);
- 2) **your and your supervisor's mandatory final evaluation form** (at the end of the internship);
- 3) **final validation** of the internship by IM **Director** ;
- 4) **credits registration** on IM study plan by the Academic Affairs Division.
