



# Applicable Tuition Fees and Installments for a.y. 2012-2013

The **4 income brackets foreseen by Università Bocconi for Bachelor programs in Economics and the Combined Bachelor and Master of Science program in Law** are adjusted to the economic and asset conditions of the student's original and de facto family, and ensure a fair system for tuition fees. Income brackets will be assigned as a result of this evaluation, starting with the highest income bracket, the 4<sup>th</sup>, and continuing through the 3 other brackets.

Students must pay the registration fee, tuition of the assigned income bracket, a regional tax and fixed stamp duties in accordance with the following table:

### Deadlines

- **The following are included in the 1<sup>st</sup> installment:** in addition to program fees, the registration fee of 240.00 euros, the regional tax of 140.00 euros and fixed stamp duties of 14.62 euros.
- Enrollment payment:  
**Advance payment on the 1<sup>st</sup> installment** 1,540.00 euros (plus MAV banks fees of 3.00 euros)
- Other official deadlines:  
**adjustment of the 1<sup>st</sup> installment**, 30/11/2012;  
**2<sup>nd</sup> installment**, 31/1/2013;  
**3<sup>rd</sup> installment**, 3/5/2013.

Any **deadlines** subsequent to the official deadlines will be indicated on each MAV bank form.

These **deadlines**, regarding the completion of income bracket assignments, will only be related to payments and penalties but not to other administrative actions such as transfers and withdrawals.

A 100.00 euros **penalty** and the **suspension** of all academic and administrative activities are applied to any overdue payments.

### Please note

- **Failure to pay** tuition and fees or any penalty fines owed makes it impossible to register for the following academic year.
- During the current academic year, the Lombardy Regional Council raised the **regional tax** for the right to study from 100.00 euros to 140.00 euros.
- For the entire duration of the course of studies, the income brackets, the registration fee and the program fees will be adjusted regarding inflation and any other updates. Program fees for the **4<sup>th</sup> year of the Law program** is subject to an increase, including inflation, of 10% over the third year (with a maximum increase equal to the tuition expected for the 1<sup>st</sup> year of Master of Science programs). As established for the fourth year, program fees for the **5<sup>th</sup> year of the Law program** will be adjusted regarding the rate of inflation and any updates.
- Students enrolled to complete a **second Bocconi degree** are required to pay tuition fees for the 2<sup>nd</sup> income bracket.
