## COMMITTEE FOR THE COMPARATIVE EVALUATION OF THE CONFERRAL OF N. 1 COLLABORATION CONTRACT AT THE DONDENA RESEARCH CENTRE OF BOCCONI UNIVERSITY

The evaluation committee composed of Prof. Andrea Colli (President), Dr. Stefan Nikolic (Secretary) and Prof. Tamás Vonyó (Member), met on 7th November 2019 at 10 a.m. in office 3.D1. 02 in via Roentgen, 1, Milan.

A total of n .4 applications were received:

According to the rules of the call, the Committee has determined that the points to be allocated are as follows:

- 40 points out of 100 for evaluation of the CV, qualifications and publications
- 60 points out of 100 for the interview

Only those candidates who achieve a score of at least 30 points for the evaluation of the CV, qualifications and publications will be invited to interview.

Having evaluated the applications submitted, the Committee has assigned the following scores:

## Interview meeting

The Committee confirms that the interview of Melinda SUKOSD took place at 15:00 on $11^{\text {th }}$ November 2019, of Filip NIKOLIC at 15:30 on $11^{\text {th }}$ November 2019, and of Omissis at 16:00 on $11^{\text {th }}$ November 2019 via Skype.

The Committee asked the candidates a set of questions relating to their CV and discussed the requirements of the job.

At the end of the interview, and after disconnecting the candidate from the Skype call, the Committee unanimously expressed a favorable evaluation of both Melinda SUKOSD and Filip NIKOLIC. Omissi Omissi explained a change in her circumstances, namely a recent offer of a full-time position that would conflict with the job announce in the present call. Therefore, the Committee unanimously agreed that she cannot qualify for either of the two positions.

Candidates who achieved a score of 60 or more are therefore as follows:
