## THEMIS REQUIREMENTS

Themis students are required to take at least 30 credits worth of courses and pass at least 24 exam credits.

Courses must be selected from a narrow list of Themis accredited courses;

Themis students are allowed to select one course (up to 6 credits) outside of the Themis list, as long as the course is open to incoming exchange students.

Themis students who do not respect the Themis program study plan requirement will be required to change their study plan.

#### **COURSE SELECTION**

Course selection will run from January 12 to 14, 2022 and courses are assigned on a first-come-first-served basis.

Classes will start on February 3rd, 2022.

Students will have the possibility to change their study plan in the period February 9-16, 2022 (upon courses availability).

After the deadline (February 16th, 2022) changes (add/switch/drop) are no longer possible.
