

Covid-19: Responsible behaviours declaration

The Covid-19 pandemic we are undergoing will have repercussions on all our daily actions for the months to come. It also entails that students demonstrate responsible behaviors in their daily routines to protect themselves and the entire community. With specific reference to the use of the Residences, they must comply with the conduct set out in the regulations you approved when applying for an accommodation assignment.

More specifically, in your daily life at the Residences you must be aware of and acknowledge the following in order to be able to face the months to come with peace of mind. This regards both the contingent social and health context and the need for general compliance with the health and hygiene rules that the Covid-19 pandemic has brought to light and which requires our proper behavior and consideration.

I, the undersigned, (first name) _____ (last name) _____:

- I. am aware of the infection risks deriving from failure to comply with the preventive measures ordered by governing bodies and of having to maintain conduct in the Residences that does not harm myself or other residents in any way;
- II. undertake not to harm my health or that of my fellow residents by complying with the rules of daily and personal sanitation, maintaining social distancing where foreseen and/or required and keeping the common areas tidy, clean and in good condition, hereby assuming responsibility for any consequences or damage that should arise either to myself or third parties from my negligent behavior;
- III. am aware that my stay in the Residence and my state of health are under my complete responsibility;
- IV. am aware that if I have symptoms of illness/cold I will have to inform the reception service of the Residence, behave responsibly and appropriately, respectful of others and that I will have to comply with the provisions set by the governing bodies and by the competent health authorities, assuming responsibility for any consequences or damage that should arise either to myself or third parties from my negligent behavior, and relieving Bocconi University in this regard;
- V. am aware and accept that the manager of the Residence or his/her delegate will be able to enter my room and/or apartment, even in my absence, in any case respecting my person and my belongings, to carry out special cleaning, painting and/or sanitation that may be required or beneficial in relation to the adoption of specific safety and containment measures deemed appropriate and/or which may be required/suggested by competent authorities to protect students, staff and guests. For this reason, I now hereby grant authorization to access my room and/or apartment. I will endeavor to leave the room tidy and free of valuables every time I am away for an extended period during the semester, in order to simplify any sanitation to be carried out in my absence. To this end, I undertake not to bring into the Residence rugs, sofas, shoe racks or electronic devices that are bulky or cannot be cleaned easily (e.g. TVs, toasters, toaster ovens), which could hinder correct and thorough cleaning and hygiene; in this regard, I am aware that Bocconi University cannot be held responsible for the damage or loss of any objects, including objects of value or those that are easily perishable by nature, left by the undersigned in the room including during possible future lockdown situations;
- VI. am aware and accept without reservation that in cases of necessity or in the event of an emergency, or for reasons of expediency connected to a critical regional, domestic or international situation/emergency, Bocconi University will have the right to close or limit access to common areas, and/or move me to another room and/or Residence, proceeding in the ways and timeframes required by the events in progress.
