According to the regulation of the competition, the Committee concluded that the maximum scores to be allocated would be as follows:

- 30 points out of 100 for the evaluation of the CV and qualifications¹
- 70 points out of 100 for the evaluation of the interview²

Only those candidates who would achieve a score of at least 20 points for the evaluation of the CV, qualifications and publications would be invited to interview.

¹ From 30 to 40 points, as per the Regulations.

² From 60 to 70 points, as per the Regulations.

The Commission asked the candidate a set of questions relating to his CV and qualifications.


At the end of the interview, and upon the departure of the candidate, the Committee, unanimously expressed positive evaluation and assigned him a score of **55** points.


