Emphasis is placed on the freedom of contracts, individuals and businesses in digital environments.

The final goal is to prepare tomorrow's professionals to find cutting-edge solutions to the legal questions emerging from fast-paced technological development and digital activities.

CANDIDATE PROFILE

The LL.M. is addressed to lawyers and current and future legal practitioners who wish to get an **internationally acknowledged curriculum** and the skills to start or further develop a promising career in law and technology in the digital era.

The program prepares participants for careers in legal practice dealing with information technology, technological sectors and digital environments at:

- digital businesses, information technology corporations and companies relying on digital assets in general

Students may complete a **curricular internship** consistent with the educational objectives of the LL.M. in the final part of the program. Alternatively, students may choose a **clinical work**, a short-term assignment by an external partner focusing on specific subjects. They may also choose to complete an individual research paper (final thesis).

PROGRAM STRUCTURE

The LL.M., **taught entirely in English**, is offered in priority as a full-time program (**12 months**), but a part-time version (2 years) is also available. This professional program features prominently hands-on activities. Close relations with specialized law firms, digital and high-tech companies and national or international regulatory institutions is ensured, also in view of internships and clinical work.

For the full-time program, all courses take place **from September 2020 until April 2021** and all practical activities take place between May and July 2021.

The program awards **60 ECTS** credits in total.

Each module and sub-module will be taught by top-tier experts and specialists of each subject.

APPLICATION AND REQUIREMENTS

Online application will open in **November 2019** and close in **June 2020**. The results of the selection process will be communicated in July 2020.

In order to be evaluated, applicants must meet the following requirements:

- a 5-year Integrated Master of Arts in Law (if from an Italian university), or eligible non-Italian degree (if from a university abroad)
- English knowledge at least at the B2 level

The selection process is based on the evaluation of a dossier including:

- Academic curriculum
- Curriculum vitae
- Personal statement
- Reference letters (up to 2)
- Interview (if needed)
