

MINUTES OF THE SELECTION COMMITTEE MEETING OF THE COMPETITION FOR THE CONFERRAL OF N. 1 PRIVATE LAW CONTRACT OF A FIXED-TERM "LECTURER" FOR THE COMPETITION SECTOR 13/D3 DEMOGRAPHY AND SOCIAL STATISTICS AT THE DEPARTMENT OF "SOCIAL SCIENCES AND POLITICS" OF THE LUIGI BOCCONI UNIVERSITY OF MILAN

The Committee meeting, convened by prof. Marco Bonetti, delegated by the Head of the Department of Social and Political Sciences prof. Vincenzo Galasso, was held on 14 November 2022 at 10:30 remotely (via Teams).

The Committee is in charge of the comparative evaluation for the conferral of n. 1 fixed-term private law contract as "Lecturer", announced by the Luigi Bocconi University on October 5th, 2022, prot. n. 11953, for the competition sector 13/D3 DEMOGRAPHY AND SOCIAL STATISTICS (SSD SECS-S/04 Demography), for the evaluation of the applications received and the identification of candidates to be admitted to a trial academic lecture.

The Committee takes note that n. 1 application has been duly submitted. The application has been analyzed based on the criteria expressed in the competition announcement. In order to possibly invite the candidate to hold an academic lecture as part of the assessment, the curriculum, the list of publications and the qualifications presented by the candidate were preliminarily evaluated.

The teaching profile required by the announcement regards courses concerning the competition sector 13/D3 DEMOGRAPHY AND SOCIAL STATISTICS (scientific sector SECS-S/04 Demography). In particular, in light of the educational needs expressed by the Department of Social and Political Sciences, the Committee takes in special account the educational background of the candidate and with particular attention to competence in the associated subjects, as well as previous teaching experience to be possibly delivered both in Italian and in English, and the areas characterizing the candidates' disciplinary interests and skills.

Based on this evaluation, the Committee formulates the following judgment:
