

**COMPETITION BY EXAM AND ACADEMIC TITLES, ANNOUNCED ON FEBRUARY 4, 2019, PROT. N. 3772 FOR THE CONFERRAL OF 1 RESEARCH GRANT WITH A DURATION OF ONE YEAR FOR THE SECTOR 12/D1 ADMINISTRATIVE LAW AT THE DEPARTMENT OF LEGAL STUDIES OF UNIVERSITÀ COMMERCIALE "LUIGI BOCCONI" OF MILAN**

**Minutes 1**

The Judging Committee of the competition by exam and academic titles for academic titles for the conferral of 1 Research Grant related to sector 12/D1 Administrative Law (Scientific Sector IUS/10) with a duration of one year at the Department of Legal Studies of Università Commerciale "Luigi Bocconi" of Milan is made up of:

- prof. Giacinto della Cananea, Full Professor
- prof. Marco Ventoruzzo, Full Professor
- prof. Fabrizio Fracchia, Full Professor

It met on April 1, 2019 at 12 am in room SR03, at Bocconi University, via Rontgen 1, Milan, to decide the scores to assign to the research and academic titles and publications.


The Committee had previously appointed Prof. Giacinto della Cananea as President and Prof. Fabrizio Fracchia as Secretary.

The Committee took note of the regulations set out in the notice of competition that the maximum points to be assigned are as follows:

- 30 points out of 100 for the evaluation of CV, academic titles and research and programming experience;
  - 30 points out of 100 for the evaluation of scientific publications presented";
  - 40 points out of 100 for the evaluation by interview.

- 100 points out of a total of 100

Only candidates who achieve a minimum of 40 points in the evaluation of titles, publications and project will be admitted to be evaluated by interview.

Taking into account the art. 2 of the competition notice and having read the applications and titles submitted by the candidates of the competition, which were all compliant with what was set out in the competition notice, the following points were assigned:





The candidate earned a PhD in Administrative Law and also carried out research activities abroad.

The CV, as a whole, taking into account the time period since graduation, demonstrates the profile of a moderately good candidate.

She declares to be author of some publications, not all pertinent to the Sector 12/D1; although embracing a quite large range of interests, they are published in not particularly prestigious journals; some of the works are included in a mainly practical book.

Despite not having yet obtained a PhD in Adm. Law, the candidate has participated as a speaker at two conferences, one of which abroad: his CV, taking into account the time period since graduation, demonstrates the profile of a good candidate.

The candidate authored some articles, all pertinent to the Sector 12/1, which demonstrate analytical skills and mastery of the topics; three of them are published on a in A-class journals.
