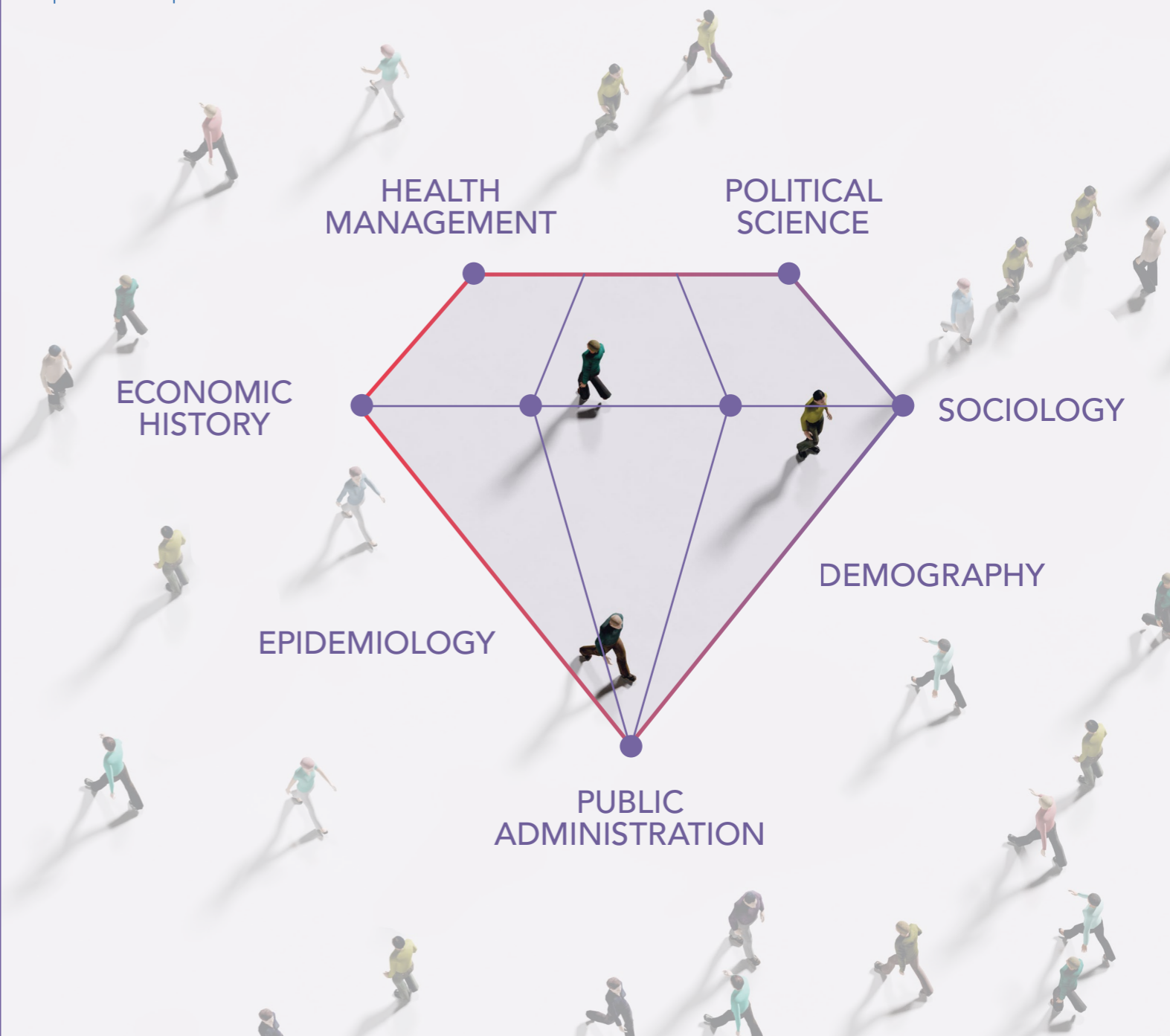

PhD IN PUBLIC POLICY
AND ADMINISTRATION



ANY STUDY OF GOVERNMENT, GOVERNANCE OR POLICY INVOLVES THE STUDY OF POWER AND ITS APPLICATION. THE PHD IN PUBLIC POLICY AND ADMINISTRATION ALLOWS CANDIDATES TO APPROACH THIS TOPIC FROM MANY DIFFERENT ANGLES, AND PREPARES THEM TO ANALYZE POLICIES WITH CUTTING-EDGE METHODOLOGY AND ESTABLISH BEST PRACTICE FOR POLICY IMPLEMENTATION. GRADUATES CAN EMBARK ON HIGH-LEVEL CAREERS AS ACADEMIC RESEARCHERS OR POLICY-MAKERS.

The program is necessarily multidisciplinary in nature, as understanding the genesis of power can involve everything from demography to economics. The question of who wields power is a matter of political science; its organization and expression occupy public administrators and healthcare managers; and sociologists seek to comprehend how people experience power. The advanced tools needed to analyze and measure the phenomena of power come from statistics and econometrics.

A year of common coursework lays the theoretical and methodological groundwork for students to begin their path of specialization among these diverse fields. In the second year they choose one of two tracks: Political and Social Science or Public Administration. Within these broad areas, they will produce a research paper and select a dissertation topic to start their migration from the classroom into the world of research. During the preparation and defense of their dissertation, students will be mentored by a member of our highly distinguished international faculty.
