The candidate was asked to present his research project in the light of his background. The candidate responded, generally speaking, in a way that was not fully convincing and without showing a good knowledge of the areas required by the project.

The candidate was asked to present his research project in the light of his background. The candidate responded in a very convincing way, showing a very good knowledge of the areas required by the project, both from a methodology and content-based point of view.

The interview ended at 11:24 am.

The Commission proceeded with the third candidate VISCONTI ANNA CAMILLA at 11:30am upon verification of her identity.

The candidate was asked to present her research project in the light of her background. The candidate responded in a partially convincing way, showing a certain knowledge of the areas required by the project, and letting emerge the need of further work and analysis in order to proceed along the relevant research path.

The interview ended at 11.54 am.

The Commission proceeded to evaluate the interviews according to the previously established criteria, and assigned the following scores:
